



## Common Human Resource Information Standards

### Training and Retired Category

Training and Retired Category is the category of a [DoD Military Service member's] training/retired category.

#### Permitted Values

- 1 - Reserve Member eligible and receiving Non-Regular Retirement pay based on 20 or more Creditable Anniversary Years
- 2 - Reserve Member eligible but not receiving Non-Regular Retirement pay due to age requirement
- 3 - Reserve Members receiving Non-Regular Retirement pay for Physical Disability and has 20 years of Creditable Anniversary Year
- 4 - Reserve Member receiving Regular Retirement pay based on completion of 20 years or more of active duty
- 5 - Reserve Member receiving Regular Retirement pay for other than age/service requirements or physical Disability
- A - Member trained/assigned to a unit and required to perform Inactive Duty Training (IDT)
- B - Individual Mobilization Augmentee (IMA)
- C - Standby Reserve Member on the Active Status List as a Key Employee
- D - Standby Reserve Member on an Active Status List Program
- E - Trained Member of the Ready Reserve not in SELRES
- F - Reserve Component Member on Initial Active Duty Training (IADT)
- G - Full Time Support (FTS) Personnel / Active Guard Reserve (AGR)
- H - Untrained Member of the Individual Ready Reserve (IRR) in the Delayed Entry Program (DEP)
- J - Ready Reserve Member not in the SELRES and participating in Officer Training Programs
- K - Ready Reserve Member not in the SELRES and participating in the Health Professions Scholarship Program (HPSP)
- L - Standby Reserve Member on an Inactive Status List vice separated due to a less than 30% service disability
- M - Special Category within the IRR subject to Involuntary Call to Active Duty
- N - Standby Reserve Member on an Inactive Status List vice separated for other reasons
- O - Ready Reserve Member not in the SELRES who are contracted Reserve Officers' Training Corps (ROTC)
- P - Personnel Awaiting IADT and authorized to perform Inactive Duty Training (IDT)
- Q - Personnel Awaiting Second Part of IADT
- S - FTS / AGR currently on or awaiting IADT
- T - Simultaneous Membership Program (SMP)
- U - Personnel Awaiting IADT and not authorized to perform IDT or receive pay
- V - Full-Time Members in support of Counter-Drug Activities
- X - Ready Reserve Member in the SELRES participating in Other Training Programs
